Terms of Participation

- A non-refundable fee of \$25 for a 10' X 10' space is required to reserve each vendor space.
- An annual, non-refundable application fee of \$50 is required to participate.
- Vendors are responsible for supplying their own canopies, tables, and display items; all items must be kept within the confines of their space.
- Vendors using canopies and/or umbrellas are required to secure these items. Any damage incurred by vendor due to improperly securing these items will be at the expense of the vendor. Canopies must be secured with 25 lb. weights on each leg.
- Fees are due with vendor application. Space will not be held unless payment is received in full.
- Applications will be reviewed and approved at the market director's discretion, including efforts to minimize duplicate product.
- *Seasonal rate* vendors must pay in full by May 1 to qualify for the discounted rate, and will be given first priority.
- Direct sales vendors will be limited to no more than 8; brands will not be duplicated.
- It is agreed and understood by all participants that they are responsible for their own space and merchandise at all times. Please do not leave booth unattended.
- Vendors are responsible for their own sales taxes and applicable fees.
- It is understood that Cedar Park Northshore Church assumes no responsibility or liability for fire, theft, personal injury, or property damage.
- Vendors must be ready for the public by 3:00 pm and will remain setup until 8:00 pm, no early tear-down.
- Vendor vehicles must be relocated to the third, upper, parking lot 20 minutes prior to Market start time.
- Vendors who cannot attend on a market day must contact the market director at least 24 hours in advance of Market Day. A \$20 fee will be assessed for *no shows* or cancellations within 24 hours.
- Advertising may be done through various outlets, including the Chamber of Commerce, City of Kenmore, Craig's List, The Herald, and Bothell-Kenmore Reporter in addition to various social media sources, and by each vendor as they help get the word out to their own customers and contacts.
- There will be no refunds except in the case of applications not being accepted.
- Smoking, vaping and consumption of alcohol is prohibited on the Market site at all times.
- Vendors' children must be monitored at all times and should not be allowed to wander the grounds unsupervised, especially during set-up and tear-down times. The Market can take no responsibility for their safety or whereabouts, or any injuries that may occur.
- Hawking (calling out, drawing attention to, vendor product in a loud way) is prohibited.
- Sampling- Special Health Department guidelines must be observed at vendor booths food demonstration and sampling.

- Vendors will be required to have proof of permits and licenses applicable to the sale of product with them at all times. Proof of insurance will be required at the time of application.
- Conduct: This event shall be conducted in a decorous manner in order to not be objectionable to other vendors, Cedar Park Northshore Church, the local police and fire departments, or the public. Northshore reserves the right to close, remove, or require changes in any exhibit or to remove any of the Vendor's personnel, agents, representatives, invitees or guests who are deemed detrimental to other Vendors, the public, or the overall Market. If the product you are selling is not consistent with the product listed in the application, or is objectionable, or detracts from, or is out of keeping with the character of the Market as a whole, Vendors will be required to remove it.
- Terms of participation may be amended, without notice, at any time by Cedar Park Northshore Church.

Agreement, and Waiver of Liability

I have read and agree to the above terms. I assume all risks and hazards incidental to such participation including transportation to and from the activities and do hereby waive, release, absolve, indemnify and agree to hold harmless Cedar Park Northshore Church, it's staff, partners, and volunteers for any claim arising from injury to myself and our representatives. Furthermore, in case of an emergency I give permission for the Market's representative to secure the emergency medical attention required. Any direction to the contrary should be noted on the registration form and signed. I agree that pictures taken during market hours may be used for future promotional purposes. I have read the *Vendor Terms of Participation* for 2018 and my signature below indicates my agreement with those guidelines and rules.
